

#### IN-DEPTH ANALYSIS OF BUSINESS

#### ASSOCIATIONS AND PRODUCER COOPERATIVES

PARS undertook an in-depth analysis of business associations and producer cooperatives in Kilifi, Isiolo, Busia and Kisumu Counties to identify their strengths and weaknesses.

Through qualitative and quantitative methods, PARS engaged county officials, KNCCI county chapters, leaders and members of these entities to understand membership structures, cooperation with other entities, policy dialogues, strategic partners, and overall service delivery to their members. The end product was an insightful report with recommendations to strengthen the agency and voice of the entities in public-policy dialogue and in advocacy for business-friendly environment ultimately contributing to economic prosperity in the respective counties.

# EARLY INFANT MALE CIRCUMCISION (EIMC) PRACTICES IN EAST AFRICA DEMAND CREATION STUDY

Early Infant Male Circumcision (EIMC) is part of sustainable HIV prevention strategies in Kenya. The goals of the national EIMC program are to circumcise at least 40% of all newborn male infants delivered at hospitals offering the service and keep the rate of moderate and adverse events below 2% (Africa Health Sciences, 2021).



PARS was thus privileged to be part of a study on EIMC in Kenya, Uganda and Tanzania as the data collection agency.

The study aimed to establish the attitudes, practices and prevalence of EIMC among the different demographic sections of the population.

### DISABILITY INCLUSIVE AND GENDER SENSITIVE VALUE CHAIN ASSESSMENT OF THE POWER-UP E-WASTE PROGRAMME

UN has 17 Sustainable Goals which aim to transform the world. Sustainable Development Goal 5 on Gender Equality envisions a world where women and girls everywhere have equal rights and opportunities and able to live free of violence and discrimination. Goal 10 strives to reduce inequality by empowering and promoting the social, economic and political inclusion of all, including persons with disabilities.

During the quarter, PARS conducted a disabilities inclusive gender sensitive assessment of the E-Waste value chain in Nairobi, Kiambu, Nakuru, Kajiado and Meru.

The assessment was mainly qualitative in nature including Focus Group Discussions and case studies with women and men with disabilities and women without disabilities. All researchers involved received a comprehensive training on disability sensitive data collection. The entire study ensured reasonable accommodation for persons with disability.



The final report highlighted experiences, barriers and opportunities for women and persons living with disability in the e-waste value chain.
